

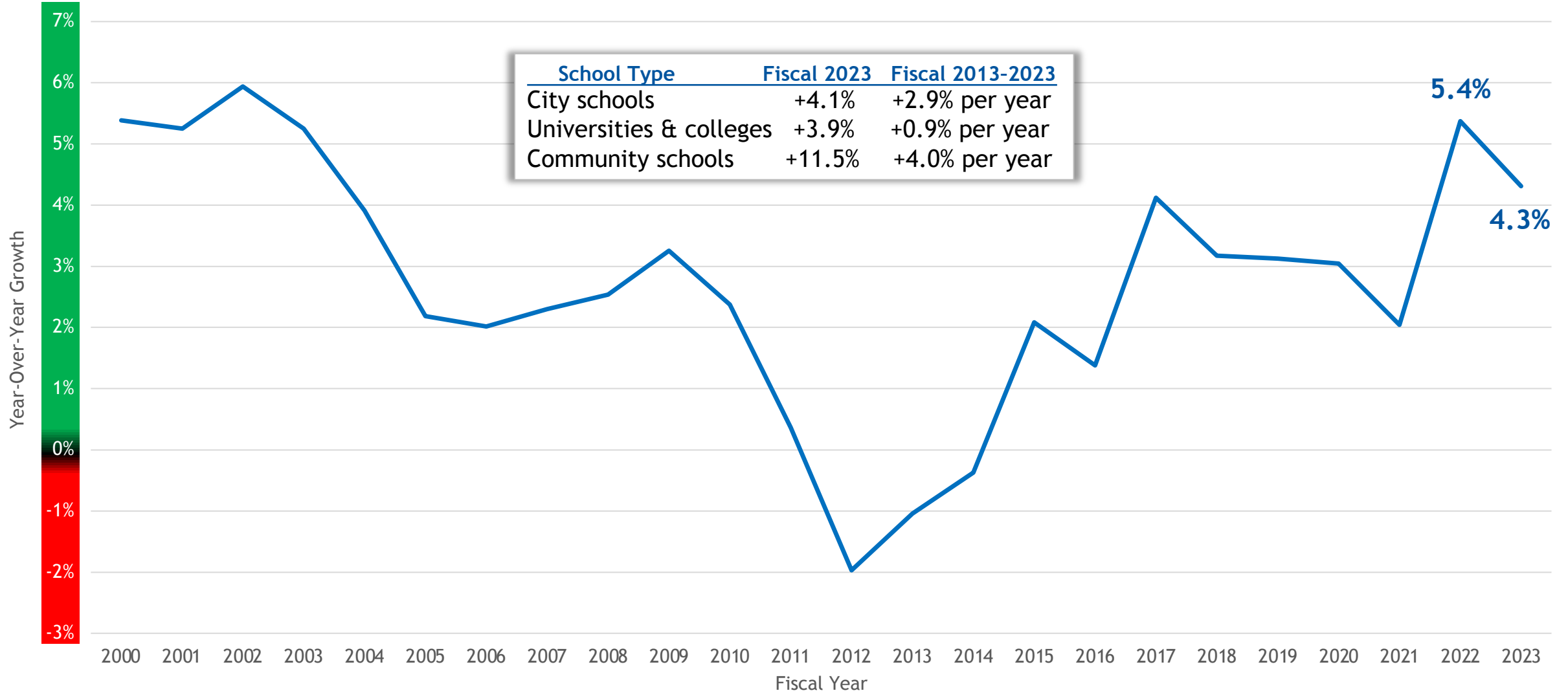

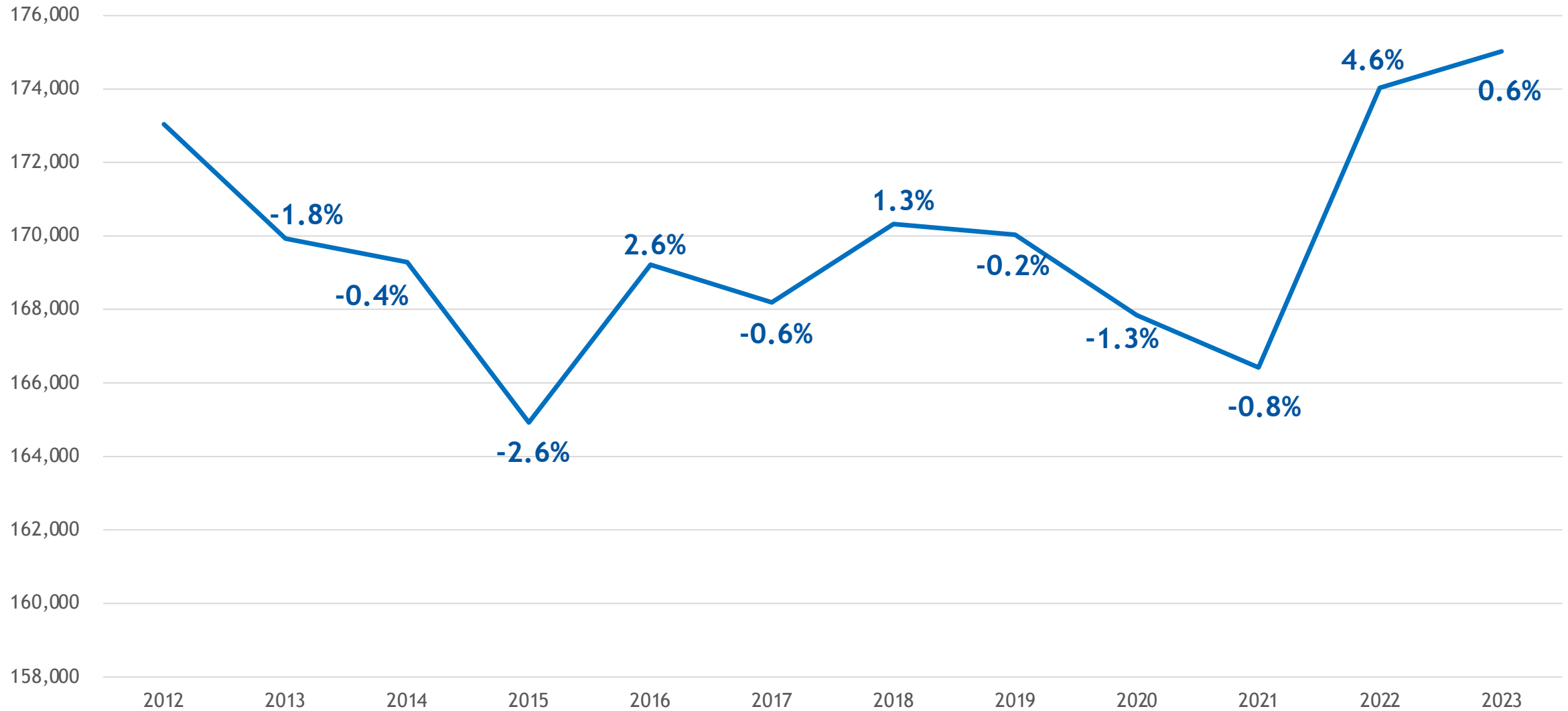

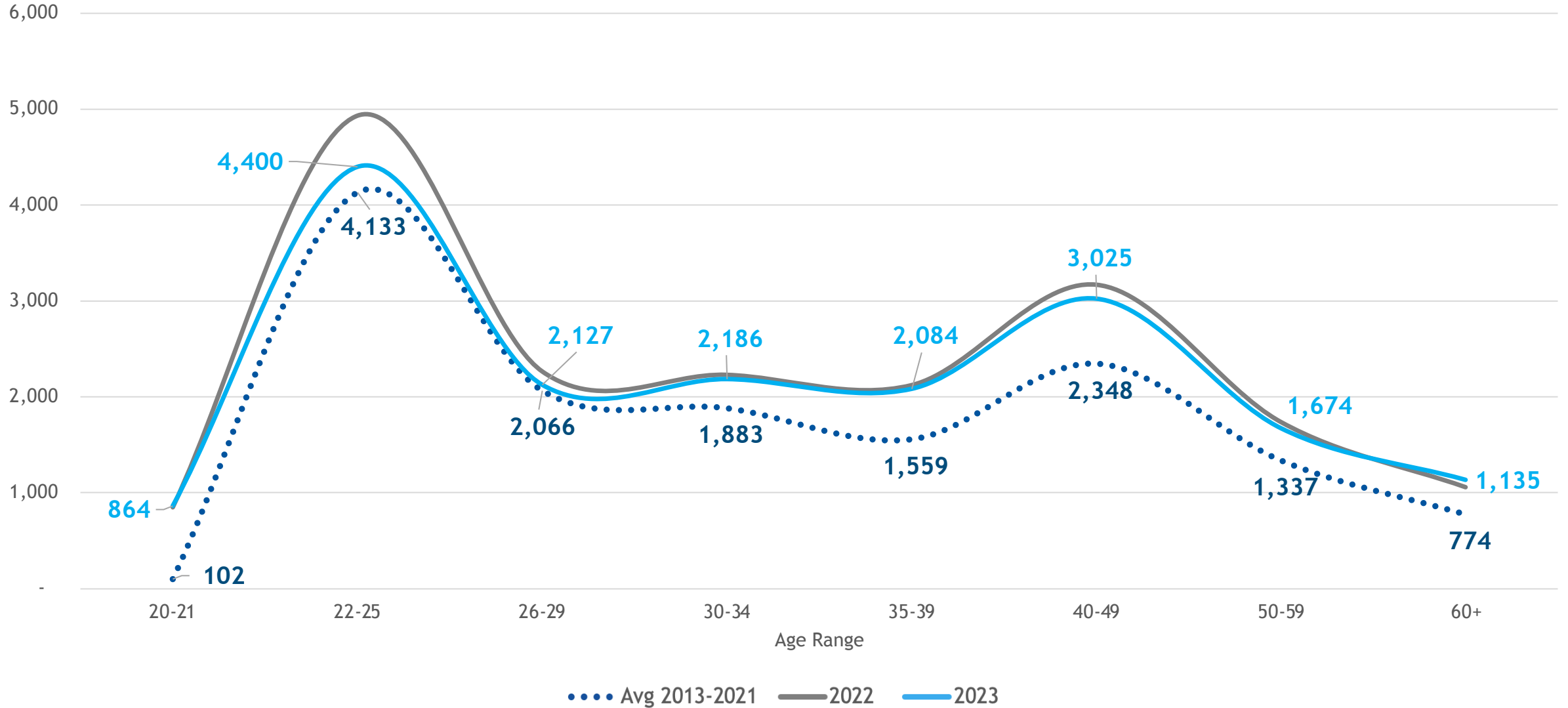
# Payroll Growth (All Plans, All Employers)



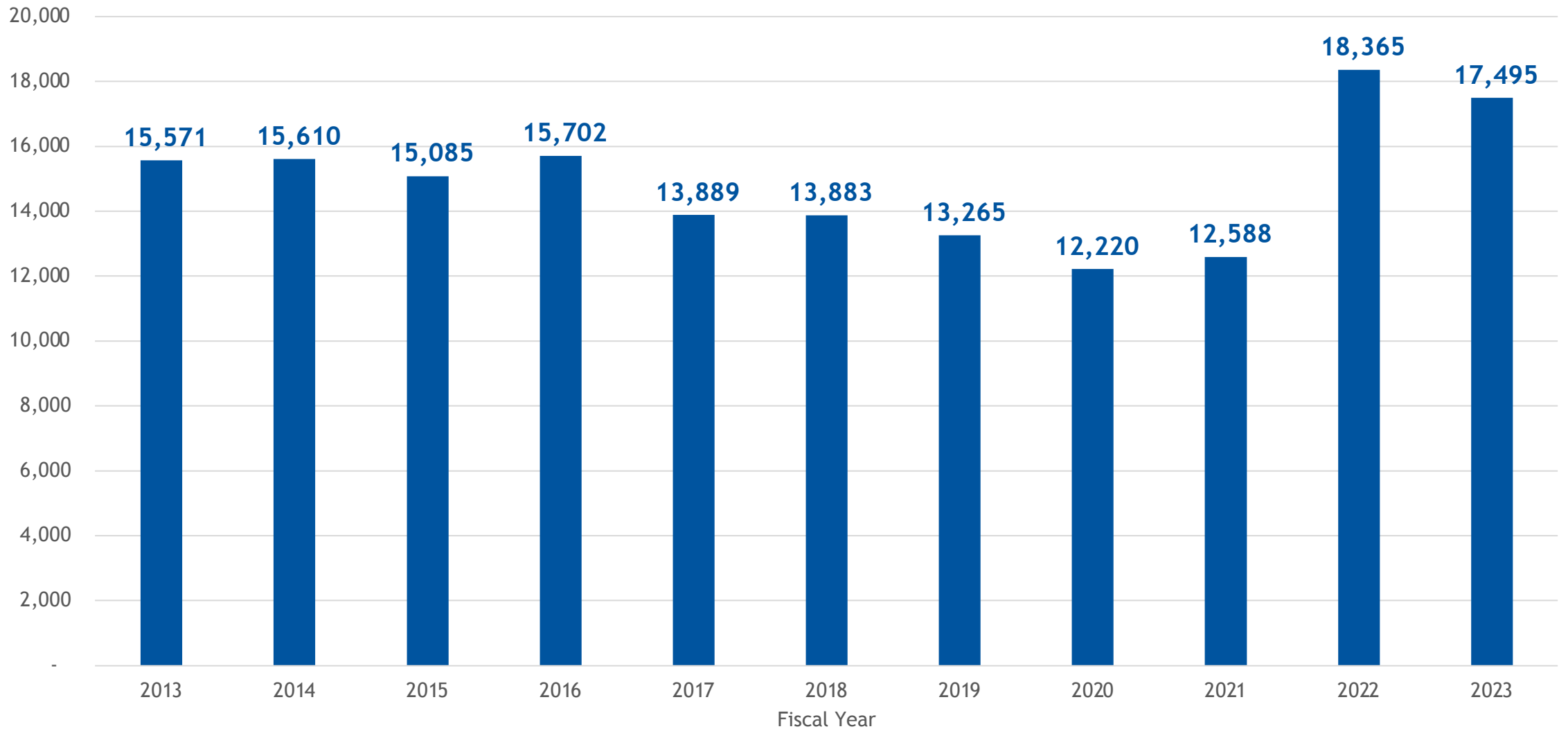
# Active Participants – Defined Benefit and Combined Plans



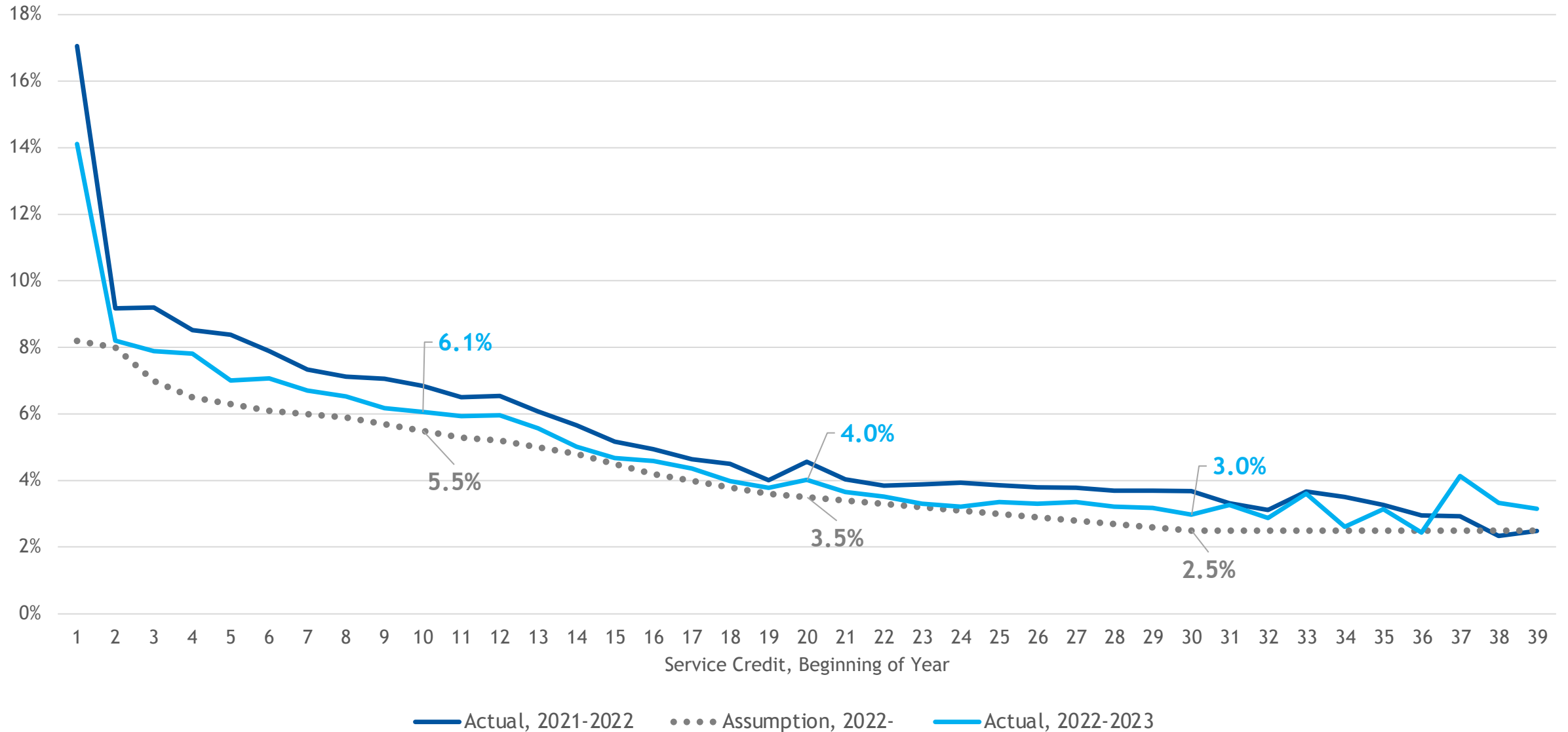
# New Hires by Age



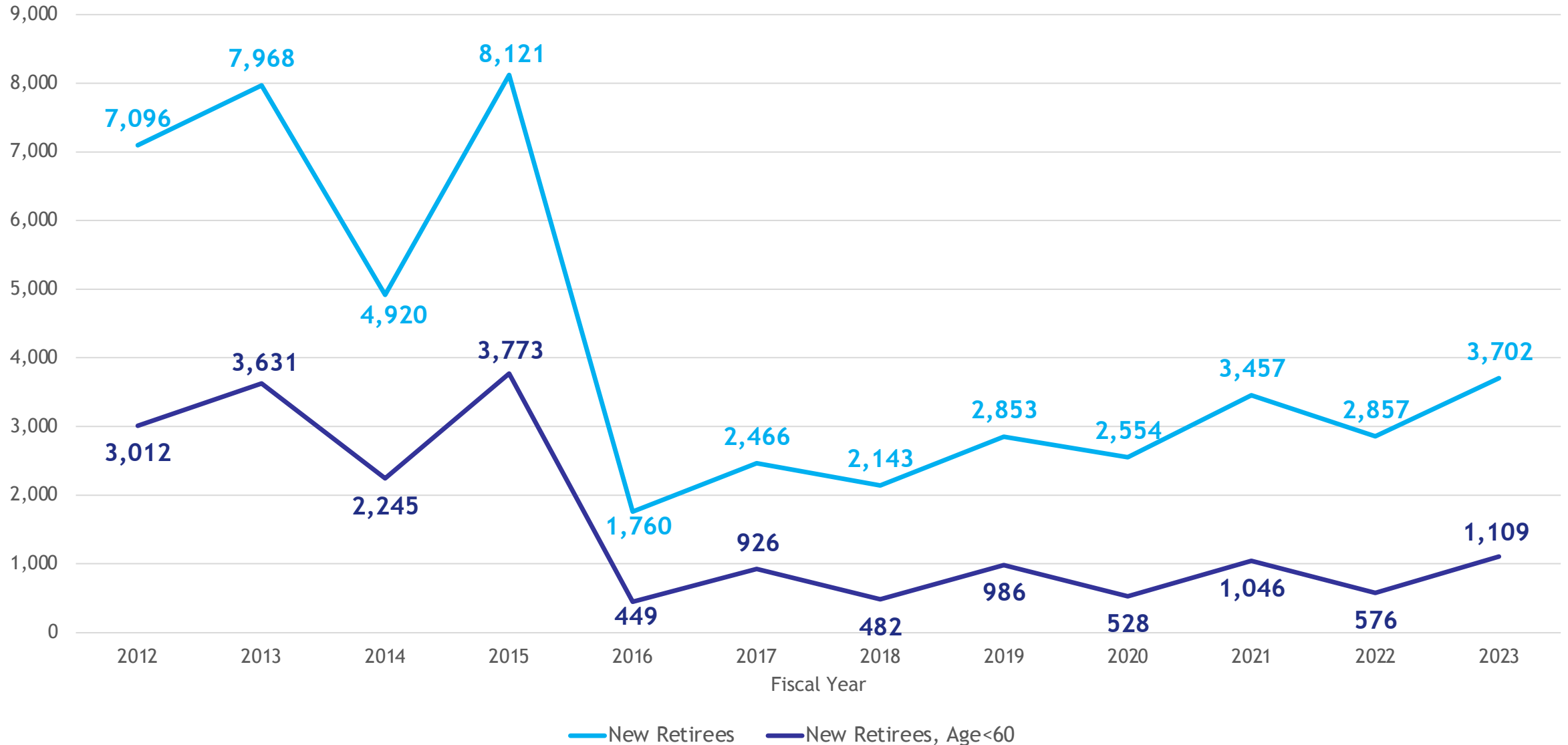
# New Hires by Fiscal Year



# Salary Increase Rates — Full-Time Active Defined Benefit Plan Members

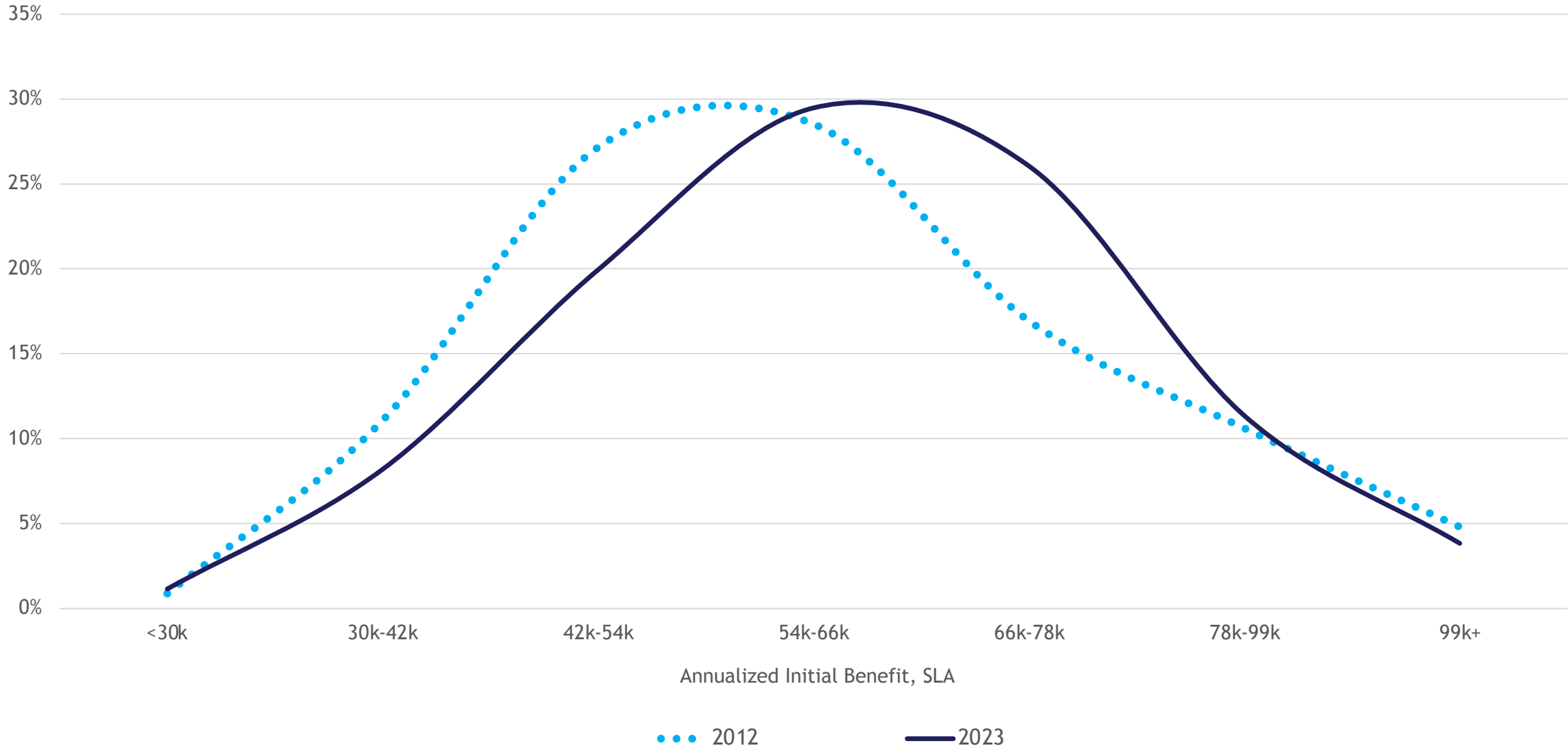


# New Defined Benefit Service Retirees

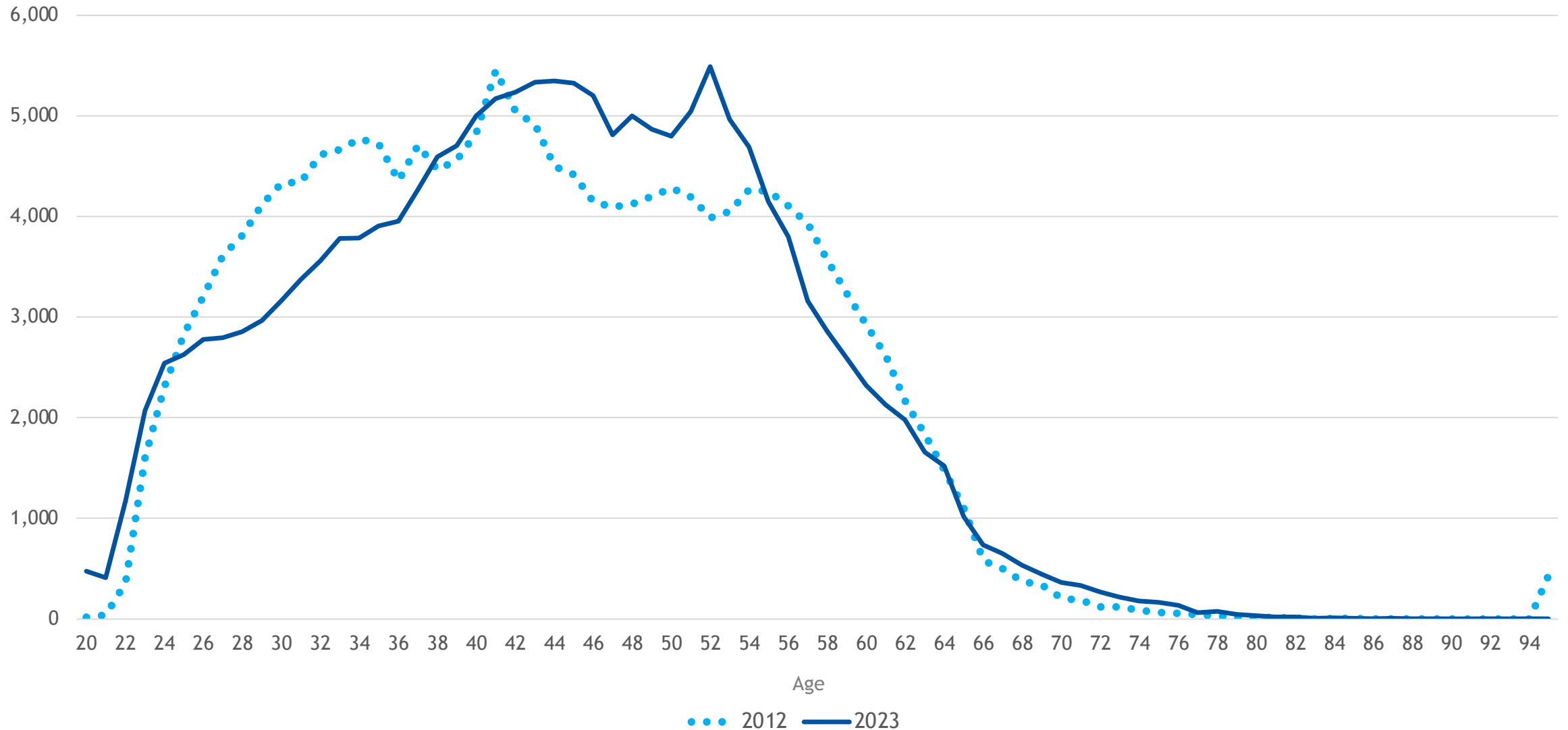




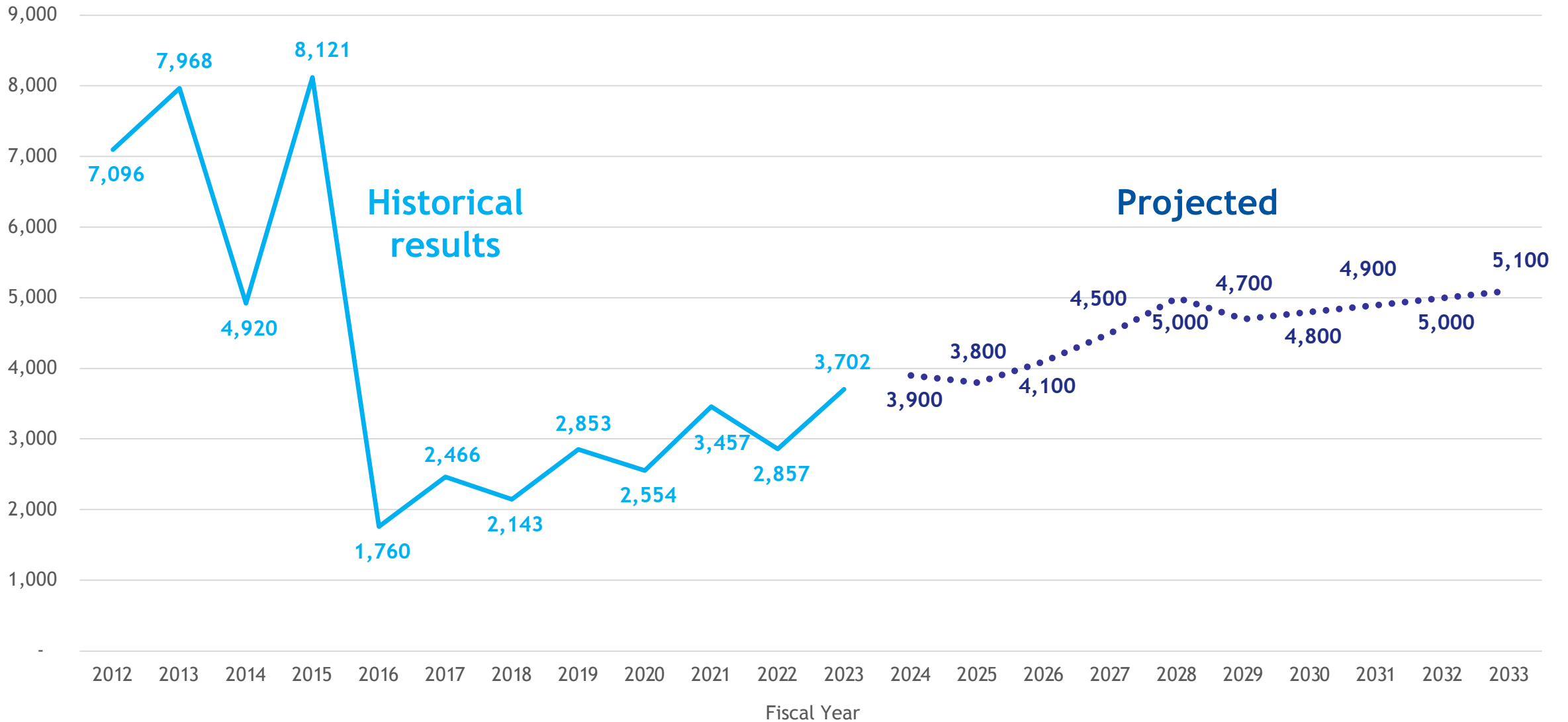
# Average Benefits – New Full-Career Defined Benefit Retirees
